

# 2012 John Tonkin College Uniform Subsidised Program

On 1<sup>st</sup> January 2012 Mandurah Senior College and Mandurah High School will merge to become John Tonkin College. All 2012 John Tonkin College students at both the PET and Tindale Campuses will be provided with a clothing voucher to purchase John Tonkin uniforms to a maximum value of \$200 (including GST).

## 1. Distribution of Voucher

In late November / early December 2011 a letter and numbered clothing voucher (to be redeemed at Hot Klobba Clothing Company only) will be posted to parents of all students enrolled in Year 8-12 at John Tonkin College for 2012 school year.

## 2. Redeem Vouchers

- 2.1 Parents are encouraged to redeem these vouchers by the commencement of the 2012 school year on 1<sup>st</sup> February 2012.
- 2.2 Vouchers can only be redeemed at Hot Klobba Clothing Company in one visit as unused amounts on vouchers will be forfeited.
- 2.3 Vouchers cannot be redeemed for cash and un-used amounts on each voucher cannot be paid to parents by Hot Klobba or John Tonkin College.

## 3. Purchase All Uniforms in One Transaction

If required uniforms are not available at the time & date of request, Hot Klobba will hold selected uniforms till uniforms on back order are available.

## 4. 2012 Students Wearing JTC Uniform

It is mandatory that all 2012 John Tonkin Students wear the approved John Tonkin College uniform to all College classes and events.

## 5. Uniform Voucher Close Off Date

All vouchers must be redeemed by 3<sup>rd</sup> August 2012.

## 6. Students Enrolling after 1<sup>st</sup> December 2011

Students who enrol after 1<sup>st</sup> December 2011 for 2012 school year will have a uniform voucher handed to them at the time of enrolment.

## 7. Students Who Leave

Un-used clothing vouchers for students who leave John Tonkin College will be cancelled and not transferable to other students.

**8. Recoup by Hot Klobba**

Hot Klobba will invoice John Tonkin College on a weekly basis, listing each voucher number and the total cost of purchases on each voucher up to a maximum of \$200 each (including GST).

**9. Voiding Vouchers**

As each voucher is invoiced to John Tonkin College, the voucher will be voided and no further payment will be made on it.

**10. Lost or Stolen Vouchers**

Vouchers that are reported as lost or stolen will be replaced by John Tonkin College if they have not been redeemed at Hot Klobba. Hot Klobba will be notified of all cancelled voucher numbers and uniforms will not be supplied by Hot Klobba.
